ITEM ONE Update

1. NICK DE MESTRE opened the discussion, noting that today's meeting will discuss the final draft articles before Board approval on 22 September.

ITEM TWO Consideration of Final Articles

2. DAN SIMPSON spoke through the slide deck which outlined the different membership categories and their respective fees. DAN also went through the existing membership definitions and their different eligibility. Members were asked for their feedback on the proposed fees in the table and were given the opportunity to provide their comments outside the meeting. The slide deck shared in the meeting can be found in the ChuK Shared Member Drive.

The proposed categories were noted as:

- 3. DAN SIMPSON noted that the fee structure will go to the Board for approval on 22 September.
- 4. ROSANNA TURNHAM questioned whether the associate rate is ambitious and noted the difference between the two different levels of associate fees. There is a possibility that those who are paying the higher fee may have issues with the fact that there is a lower one.
- 5. DAN SIMPSON clarified that potential associate members, such as banks, noted they would be willing to pay a higher fee hence why the fee structure reflects this.
- 6. VICKY READ asked whether the start-up category is for those 'starting up' in the UK for the first time or just general start-ups.
- 7. NICK DE MESTRE suggested that it could be amended to refer to CPOs and suppliers in the UK, e.g., you can't be a full member if you are not in the UK. NICK noted that the Board will still get some discretion in arguing whether members are able to join but the categories above are more broad outlines.
- 8. DAN SIMPSON ran through the delegated matters: Operations Group, Policy Group and Communications Group. This was following previous suggestions to separate the PCG into two separate groups for Year 2. DAN asked members for any final comments and feedback.
- 9. ROSANNA TURNHAM noted the structure looks reflective but noted apprehension with the Board Directors piece. ROSANNA questioned whether this was asking CPOs to take a statutory function as this is quite a big obligation.

- 10. NICK DE MESTRE noted he was unsure how this could work in any other way but would welcome any suggestions to amend this. Having an advisory board with statutory requirements would be good but this would be quite difficult to do this at this stage.
- 11. DAN SIMPSON noted that ChargeUK needs its own legal identity and will need somebody appointed on a Company's House basis. Instead of having every member appointed as a CH director, it could be just the Chair and Vice Chair of ChargeUK.
- 12. ROSANNA TURNHAM noted that it was quite a big obligation so is concerned if there is no other way around it. NICK DE MESTRE noted it was a good point and that ChargeUK could limit just the Chairman to have this statutory obligation.
- 13. ROSANNA TURNHAM asked for an indiciation as to who has shown interest in associate membership. DAN SIMPSON noted that there has been a wide range of interest, from tech companies to banks, insurance companies and larger consultancies.
- 14. DAN SIMPSON thanked all members for attending and for their feedback, noting that the next Operations meeting is scheduled for the 12 October.
